PET SITTING SERVICES AGREEMENT

The parties hereto agree to the following terms & conditions:

1. The initial term of this contract shall be ongoing until Client cancels service. Client warrants and represents that all information provided to MCPS in its Client Information Forms (hereby and hereafter called "Client Record") is accurate and agrees to notify MCPS of any changes/updates to Client Record.
2. Upon Client's request to provide services in the future via phone, email or in person, Client agrees that this contract shall be renewed or extended in its entirety, without further written authorization. The term of said renewal shall coincide with the service dates as listed on the most recent of an email confirmation or an invoice.
3. MCPS may update its prices at any time without prior notice. Client agrees to pay rates as posted on company website mocopetsitters.com at time reservation is confirmed. Client agrees to pay any additional fees as defined in the price list on the company website for services performed in addition to those agreed to in the initial reservation.
4. This contract authorizes MCPS to enter the Client's home to provide the services listed herein. In the event that MCPS is required to employ a locksmith to gain entry into Client's premises due to a malfunction of the lock or a failure of the Client to leave a key, it shall be the responsibility of the Client to reimburse for all costs incurred. The Client expressly gives MCPS the authority to employ a locksmith on Client's behalf in the event of the aforementioned occurrences.
5. Client agrees to grant Montgomery County Pet Sitters permission to transport any of his/her pets to his/her primary veterinarian (or to closest facility in event of emergency). Client gives permission for the hospital/doctor to administer whatever care/medications necessary to care for the pet(s), with the exclusion of euthanasia and/ or the following: _____.
6. Client agrees to indemnify MCPS from liability, including attorney's fees, arising from any injury or damage to MCPS employees, third parties or real/personal property of third parties as a result of actions of pet(s). Client agrees to disclose to MCPS any known pet aggression behavior.
7. MCPS reserves the right to terminate this contract at any time before or during its term if MCPS, in its sole discretion, determines that a danger exists to the health or safety of MCPS employee. If concerns prohibit MCPS from caring for pet, Client authorizes pet to be placed in a kennel, with all charges to be charged to the Client.
8. This Contract may be executed by facsimile, and will be deemed effectively executed upon the receipt, duly executed by the other party with all charges there from to be charged to Client.

Client authorizes this signed contract to be valid approval for future services for any purpose provided by this contract permitting MCPS/company to accept telephone reservations for service and enter premises without additional signed contracts or written authorization.

Client has filled out a Client Information Form and supplemental Additional Pets Form and Medication Form, if applicable. Client has reviewed this form in its entirety, and Client understands and agrees to the policies & procedures.
